Call to Order

Chairman Judson called the meeting to order at 7:00 p.m. and Trustee Seely began the meeting with prayer.

Board Announcements

Chairman Judson announced a closed session following item 601 to discuss Legal and Personnel Matters.

Chairman Judson asked the Trustees if they had any announcements they would like to make.

No announcements were made.

Open Forum Time

Chairman Judson asked if anyone requested to address the Board. No requests were made.

Chairman Judson asked for a motion and second to approve the consent calendar.

Trustee Faith Boyd made a motion to approve the consent calendar and Trustee Kim Wyatt second the motion. The motion passed unanimously.

Board Recognitions

The Board of Trustees recognized the Finance Team for receiving the Government Finance Officers Association Award on the 8-31-2023 Annual Comprehensive Financial Report.

The Finance Team has received this award for the 22nd consecutive year. Dr. Kevin Fegan thanked the team for all their hard work. Certificates were presented and pictures were taken with team members.

Update on Enrollment

District President Dr. Kevin Fegan presented the enrollment update in Sina Ruiz absence.

Semester credit hours are up 3% and headcount is up 2% as of August 22, 2024.

The percentage of goal achieved for Fall as of August 22nd is 88% headcount, 91% contact hours, and 92% semester credit hours. Dual credit is continuing to show growth.

Finance and Operations

Vice President Teresa Thomas presented the July 2024 Financial Statement.

Budget changes for July were \$193,341 for Adult Education Grant

Year to date ending July 2024 source of funds show earned percentage of 89.08% Academic Student Income, 83.93% Continuing Education, 113.47% Local Appropriations, 99.09% State Funds, and Auxiliary Fund 93%. Expenditures are up slight due to raises in January and the debit service fund is staying constant.

The disbursement of funds is lower than July 2023 by \$3.4 million and revenue is higher by \$4.2 million. Budget to actuals E&G Fund shows \$8.5 million and Auxiliary \$1.4 million not spent as of July 2024. As of the end of July 2024 the available cash to cash equivalents are Auxiliary \$701,988, Education & General \$21.9 million, Other Cash Accounts \$2.3 million, and Investments \$2.4 million. The average monthly expenditure budget covered by available cash as of July 31, 2024 is 3.76%.

Chairman Judson asked for a motion and second to approve the July Financial Statements.

Trustee Loran Seely made a motion to approve the July 2024 Financial Statement and second by Trustee A.L. Atkeisson.

Adoption of 2024-2025 Fiscal Year Budget

The proposed budget for FY 2024-2025 is \$83 million, based on flat enrollment, balanced with no expenditures coming from Fund Balance and balanced with projected grant funds included. Total allocations without grants are \$43.3 million, grants \$1.6 million, debit service fund \$2.1 million, auxiliary fund \$10 million, and student financial aid \$25 million.

Chairman Judson asked for a motion and second to approve the adoption of 2024-2025 Fiscal Year Budget.

Trustee Richard Aldama made a motion to approve adoption of 2024-2025 Fiscal Year Budget and Trustee Todd

McGraw second the motion.

Declare intent to set Ad Valorem Tax Rate for 2024 (FY 2024-2025) on September 10, 2024

The no new revenue tax rate is \$.0894/\$100, voter-approval tax rate \$.0968/\$100, and current tax rate \$.0960/\$100. The certified tax value is \$7.674 million. Chairman Judson called on each Trustee to state if they are for or against setting the tax rate at \$.0968 per \$100 valuation.
